

## DISCLOSURE AND WAIVER OF LIABILITY

Hopefully your stay on Banwa Private Island (the "Island") will be without any mishaps, however if you, or anyone traveling with you, requires medical attention, there is some important information you need to know:

- There is no hospital on the Island.
- There is a clinic on the Island with limited resources staffed by a registered Nurse.
- First aid kits are available through the on-island clinic for the treatment of minor conditions.
- There are no pharmacies on the Island. You shall solely be responsible in ensuring that you have an adequate supply of medications that you and those accompanying you may require for your trip to and from the Island and the entire duration of your stay on the Island.
- Conditions requiring serious professional medical treatment will require you to leave the Island.
- If you, or someone travelling with you, must be evacuated in an emergency, Banwa Private Island will assist to the best of their ability with the process. Patients will be sent to either a hospital in Manila or Puerto Princessa, depending on the nature of the emergency and best option as deemed by the airlift medical staff.
- We can coordinate with our accredited aviation company for any emergency air evacuations. The cost for air evacuations ranges from \$16,000 to \$52,800 depending on the urgency.
- Emergency evacuations may not be safe or possible during the night or bad weather.
- You are solely responsible for the costs of emergency evacuations and/or any medical treatment for yourself and family members, including any minor children accompanying you.
- Emergency evacuation services and local health care providers may not accept your health insurance and may require immediate payment for services. Obtaining international insurance coverage and medical evacuation insurance is your sole responsibility.
- In the event of an emergency evacuation, the health care facility you are transported to may have significant delays in providing treatment and may be of a caliber less than what you are accustomed.
- Before travelling, review the website provided by your nation of origin for the latest information on the Philippines prior to traveling to the Island.
- THE ISLAND IS REMOTE AND HAS LIMITED ACCESS. IT IS EXPRESSLY ACKNOWLEDGED AND UNDERSTOOD BY YOU THAT IN THE EVENT YOU AND/OR ANY OF YOUR FAMILY MEMBERS IS INJURED, THERE COULD BE A SUBSTANTIAL PERIOD OF TIME (AND DISTANCE TO TRAVEL) BEFORE THE REQUIRED MEDICAL ASSISTANCE IS AVAILABLE AND EMERGENCY EVACUATION WILL BE AT SUBSTANTIAL EXPENSE TO YOU AND/OR YOUR FAMILY MEMBERS.
- You understand that there are inherent risks staying on the Island and participating in activities on or around the Island because the Island is remote, there is a lack of medical services available on the Island, and there may be an extended period of time before you are able to access adequate medical services off the Island. Knowing the risks above, you voluntarily assume all risks including those resulting from the negligence or fault of others, and also including the risk of death, serious bodily injury, or other personal or property damage associated with or resulting from travelling to or from the Island, staying on the Island, participating in activities on or around the Island, and any lack of medical care facilities or services.
- Having assumed the risks, you unconditionally waive and release, agree not to sue, and also agree to
  hold harmless and indemnify Providers (as defined below) with respect to all actual or potential costs,
  damages, liabilities, losses, expenses, or claims (including, but not limited to, attorney's fees, court costs,
  expert witness fees, and expenses) of any kind, including, but not limited to, those arising from death,
  serious bodily injury or property damage suffered or incurred by Providers, you, and/or your family
  members, including also minor children who may accompany you on the Island, related to or resulting



from travelling to or from the Island, staying on the Island, participating in activities on or around the Island, and any lack of medical care facilities or services, whether foreseeable or unforeseeable, including those resulting from negligence or fault, without regard to any hazards that may exist, whether hidden or obvious, whether natural or manmade, EVEN IF CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF PROVIDERS. You will look solely to your own assets to satisfy any and all expenses arising from any injury or loss you or your family members may sustain.

- This medical services disclosure is in addition to and supplements the Release and Indemnity Agreement signed by you in favor of Ecoresort Development Corporation doing business under the trade and style of Banwa Private Island ("Banwa"), a Philippines registered Corporation, and delivered to Banwa in connection with your arrival/stay on the Island (the "Release Agreement"). As used in this medical services disclosure, the term "Providers" shall have the meaning given in the Release Agreement. The terms of the Release Agreement are incorporated into and form a part of this medical services disclosure as though the Release Agreement were set forth in its entirety herein, including without limitation, the notice, dispute resolution, venue, and governing law provisions contained therein. You acknowledge and agree to be legally bound to the foregoing. If a minor is accompanying you, then your signature below is not only on behalf of you, but also on behalf of each minor guest listed below.
- You agree that children or minors must be accompanied by supervising adults at all times to ensure safety against any accidents
- Name and passport details of all Guests will be provided to Banwa Private Island prior to arrival
